END USER LICENSE AGREEMENT FOR PROSYS OPC TO DATABASE (OPC2DB)

1 Grant of License

These license terms cover Prosys OPC to Database (OPC2DB) software (hereinafter referred to as "Software") licensed by the user hereunder ("You" or "Licensee"), unless specific other license terms are stated.

Prosys PMS Ltd (also referred to as "Licensor"), Finnish company with domicile in Espoo and address Tekniikantie 14, FI-02150 Espoo, Finland, grants you the right to use the Software subject to the following terms.

2 Period of Agreement

This agreement will enter into force when you install or use this Software for the first time. By installing or using the Software you undertake to comply with the terms of this agreement.

3 Evaluation/Demonstration versions of the Software

You may use some versions of the Software for evaluation/demonstration purposes. The use of such versions of the Software for other purposes (including use in your business activities) requires a purchase of a valid license, which you can obtain from the Licensor against a payment of the license fee.

You shall restrict your use of any evaluation/demonstration version of the Software for evaluation/demonstration purposes only.

Any feature of the Software is subject to change without notice.

You are not allowed to distribute materials produced by the Software, regardless of the way how such a distribution takes place. You are not allowed to modify any material produced by the Software, including but not limited to computer files which were created as a result of the usage of the Software. You are not allowed to sell, rent, lease or otherwise use commercially any part of the Software or any files or parts of files which were created by the Software.

If you are an educational non-profit institution and you have got a separate written permission from Prosys PMS Ltd, you can use evaluation/demonstration version of the Software also for educational purposes.

In case the Software or any part of the Software includes server functionality, Prosys PMS Ltd shall have the right to charge for the connections to the server or for the use of server functionality according to its applicable price list.

For a single computer attached or not attached to a network, or for a server, the Software is considered in use when any portion of the Software is either loaded in memory or virtual memory, or stored on a hard disk or other storage device. The quantity of the Software in use is considered to be the maximum number of computers and network stations on which the Software is either loaded or stored at any time.

You are not allowed to modify or copy the Software except that you may make one copy solely for backup or archival purposes.

Except as provided in this License Agreement, You may not transfer, rent, lease, lend, copy, modify, translate, sublicense, time-share or electronically transmit or receive the

Software, media or documentation. You acknowledge that the Software in source code form remains a confidential trade secret of Prosys PMS Ltd or its suppliers and therefore you agree not to modify the Software or attempt to decipher, decompile, disassemble or reverse engineer the Software, except to the extent applicable laws specifically prohibit such restriction.

If you purchased this Software as an upgrade, it constitutes a single product together with the product that you upgraded and may not be used to increase the total number of licensed copies of the Software. You may use the upgraded product only in accordance with this License Agreement and you may not transfer this Software or the product you upgraded unless they are transferred together as a single product.

5 Rights to the Software

Any reproductions of any portion of the Software by the Licensee shall include any proprietary and statutory copyright notices present in the original Software.

6 Termination of the License

Notwithstanding the provisions above, the Licensor shall have the right to terminate this Agreement with immediate effect in case of any fundamental breach of the Agreement by Licensee.

On the expiration of the Agreement the Licensee shall return to the Licensor the Software and the support material or verifiably destroy it.

7 Limited Warranty

Prosys PMS Ltd warrants that the Software, as updated and when properly used, will perform substantially in accordance with its accompanying documentation, for a period of ninety (90) days from the date of receipt. Any implied warranties on the Software are limited to ninety (90) days.

Prosys PMS Ltd's entire liability and your exclusive remedy shall be, at Prosys PMS Ltd's option, either (a) return of the price paid, or (b) repair or replacement of the Software that does not meet the Limited Warranty and which is returned to Prosys PMS Ltd with a copy of your receipt. This Limited Warranty is void if Software fails as a result of accident, abuse, or misapplication. Any replacement Software will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer.
